Sealed quotations are invited on or before 3 p.m. of September 16, 2017 from the reputed manufacturers/ authorized dealers only for supply of items as detailed in the tender paper(for details see: [www.buodisha.edu.in](http://www.buodisha.edu.in)). The tender papers can be downloaded from the university website and duly filled in tender papers should be submitted along with bank draft of Rs 500( non refundable) towards cost of tender paper and Rs. 1000/- as EMD payable at Bhanja Bihar in favour of Director, Innovation-cum-Incubation Centre(IIC), Berhampur University. The Director, IIC reserves the right to accept or reject any or all quotations without assigning any reason thereof.

Terms and Conditions:

1. The tenderer must be a Registered Dealer under GST Act.
2. Tenders should be submitted on or before 3 P.M. of September 16, 2017 and it would be opened on the same day at 3.30 P.M. in the presence of the supplier if any
3. The rate should be quoted for the specified items only.
4. The rate should remain valid up to 31/03/2018.
  - a) The rate should be F.O.R Berhampur University basis and inclusive of all Govt. levies, taxes etc.
  - b) The rate should be inclusive of packing and forwarding charges, insurance and other incidental charges.
  - c) Prices quoted must be in Indian Rupee only.
- a) Delivery period for each item should be mentioned. Ex-stock delivery will be preferred.
- b) If the delivery of the items ordered are not made as per agreed terms and conditions, the purchaser will have the right to procure the items from alternative source as he may think fit and to claim the difference in rates and other related

- expenses, if any, from defaulting party and in such a case, the amount deposited as EMD will be forfeited.
5. The Director, Innovation-cum-Incubation Centre will be the final authority and his decision will be binding, in case of any dispute or complaint arising from or about the tender or any part thereof.
  6. Onsite delivery of all items and installation at the Self Help Group Office, Gopalpur
  7. Any legal dispute pertaining to the tender shall be subject to be settled in jurisdiction of Orissa high court.
  8. The Director, IIC shall have the right to accept or reject any or all tenders, without assigning any reason thereof.
  9. The amount of EMD deposited shall be refunded only after all the terms and conditions of the tender have been fulfilled and after the items have been received in good working conditions and installation.
